WHAT HAVE I BEEN DOING DURING THE PANDEMIC...?



2021 Retirement Bills

The New Hampshire Legislature proposed the following retirement bills for the 2021 session:

HB130-relative to administration by the retirement system of certain health care premium deductions.

HB173-requiring the independent investment committee of NHRS to report investment fees.

HB274-relative to payment by the state of a portion of retirement system contributions of political subdivision employers.

CACR6-relating to the retirement age of judges. Providing that the retirement age be increased.

HB248-relative to the judicial retirement plan.

HB356-relative to the city of Manchester employees' contributory retirement system.

HB211-revising certain benefit provisions in the city of Manchester employees' contributory retirement system.

HB497-allowing a school district to exempt its chief administration officer from compulsory participation in the retirement system.

HB390-FN-L-relative to the amortization of retirement system unfounded accrued liability.

HB619-FN-designating police and fire dispatchers as group II members of the retirement system.

HB536-FN-relative to death benefits for public works employees killed in the line of duty, and relative to workers' compensation offsets for certain retirement system benefits.

CACR12-repealing the retirement age for judges.

SB72-relative to a state share of retirement system contributions by employers.

SB119-relative to the ordinary death benefit in the retirement system.
