in getting a one-time stipend of \$500 for qualified members that should be paid in the spring, 2024.

Our most pressing difficulty is recruiting, engaging and retaining members. Many of our local units have disbanded for various reasons. Many lack members willing to step up to leadership roles, while others have difficulty contacting new members. The state group has experienced the same difficulties. It has been my pleasure to serve in a leadership role in NHREA since 2004 becoming president in 2010. 2023 Legislative Report

There are 12 retirement bills introduced in the 2024 legislative session. Three of these bills pertain only to Group 2 (police and fire). Three deal with the management of the retirement system.

The remaining 4 bills could have an impact on Group 1 retirees or potential retirees. None of the bills would increase pensions this year.

SB309-relative to the vesting period for members of the state retirement system from 10 years to 5 years. This bill is currently in committee.

HB1307-providing a supplemental approbation for members of the retirement system receiving an accidental disability retirement allowance.

HB1279-relative to payment by the state of a portion of retirement system contributions of political subdivision employers.

\$B368-relative to service allowances for teachers and other group 1 retirement system members.

Mind the Gap

On Jan 31, 2024, I testified before the Senate committee about SB 368. This bill would affect approximately 3000 Group 1 employees. SB 368 would capture the gap that got overlooked last year when HB 2 was passed. HB 2 changed the manner of reducing a retiree's annuity to their full retirement age. Previously the reduction was taken at age 65. Because the bill passed with a date of July 1, 2023, anyone that had retired before that date, and was not yet at their full retirement age was excluded. SB 368 would apply to any retired member of group 1 who retired prior to July 1, 2023, and who has not attained age 65 prior to July 1, 2024. I did point out that even with some one-time bills that have been passed the retirees have not had a COLA in quite some time. This bill is overdue.

There were several state employees that testified in favor of the bill. There was also discussion of the intent of last year's bill. Did it mean to capture all retirees not just those retiring after July 1, 2023?

I urged the committee to pass this forward with their recommendation.
